#### 23/41 Role Region Can Play in supporting Counties and Clubs in 2024:

23/41.01 IC outlined the work being done on the strategy, disciplines and various work streams of the region, we are seeking ideas and suggestions on how the region can further support counties. Current work that will take place is;

- Quarterly update on affiliations and accreditations
- Reinstate a Regional Chairs Forum and a new Welfare Forum for our relevant club officers.
- 23/41.02 AE raised a question on mandatory attendance at workshops in relation to Club Affiliation for Club Chairs, Membership Officers and Club Welfare Officers. JD provided a brief update from Helen Weeks but IC and JD said they would investigate further and supply full update.

Please note the following information was received after the meeting -

"From November -

- The Foundations of Inclusivity is part of the EDI addition to Swim Mark and Club Affiliation and will be mandatory from then but will be checked at time of renewal so some clubs may wait until their renewal in April / July etc.
- The Governance Workshop will be mandatory for Chairs and Welfare Officers
- Foundations of Inclusivity is a recommendation for Chairs, WO, Head Coach and whoever else it could be relevant to, as it is free."

23/42.01 PP requested contact with JD regarding and update on actions regarding Luton Diving Club. This will be followed up outside the meeting.

CV updated the forum on his intention to step down as the Chair of the Forum. AE thanked CV for his commitment and dedication to the group and for providing such a welcoming environment, which was echoed by the group.

AE requested an update on the repair works at Basildon 50m pool. IC had no update at present, but once information is available the relevant clubs, county and individuals will be involved in the discussions.
