Swim England Handbook 2024 – updates

The Swim England Handbook 2024 has been updated, which is effective from Tuesday 3rd September, with updates including:

- Amendments to regulations relating to membership
 Incorporating Swim England's new Judicial and
- Incorporating Swim England's new Judicial and Safeguarding Regulations.

Changes to the regulations are made specifically to Safeguarding, Club complaints, Judicial complaints, Introduction of a Disciplinary officer and Water Polo complaints.

Reporting a concern

Safe Supervision

Swim England have made a number of changes to the "Safe Supervision of Programmed Swimming Lessons and Training Sessions in Swimming Pools" document.



It is important that the guidance in this document is followed if your club delivers programmed sessions for example, coaching sessions or swimming lessons.

This will help you to understand your key responsibilities for these sessions, for example, the need to provide lifeguard cover where this isn't part of your agreement with a pool operator.

What actions do I need to take?

- 1. Read through the document and familiarise yourself with the requirements
- 2. Share this document with anyone in your club that runs pool sessions
- 3. Attend one of our online briefing sessions to learn more about Safe Supervision
- 4. Review your club's current position rescue qualifications and risk assessments

Para-Swimming Officiating CPD

This CPD will give an overview of Functional Classification System, Terminology & Sport Class Overview including knowledge of World Para Swimming (WPS) rules and rule exceptions.

The CPD is free and attracts 3 points towards the renewal of the AquaGB Officials Licence.


