### 25/08 AquaticsGB/Swim England Updates

### 25/08.1 Referee Candidates 2025

Applications for officials to enrol on the AGB Referee course opened in December 24, applications close 31-01-25. County Coordinators are to endorse all applications approved/not approved and forward onto DM to endorse and send to HA.

### DM reminded everyone the criteria required in England:

- Applicant must be qualified as a Judge 2S and have completed a minimum of 50 recorded hours across all roles of officiating and at a variety of levels of meet since the date of qualification as a J2S or within the two year period immediately prior to application for referee training, whichever is more recent. (This is in addition to the 10 hours consolidation required post-J2S qualification.)
- Applicant must obtain the approval of their County/Regional Officials Coordinator before applying and provide them with evidence of the 50+ signed hours (by officials' log book or similar). Swim England – Signed or email confirmation from County and Regional Coordinators
- Applicant must attend the online CPD "Para-Swimming Officiating" before undertaking their final practical assessment.
- **England and Wales only** Applicant must have completed the online course "Refereeing Swimming A Beginners Guide", available via the Institute of Swimming, before applying to commence training.



## 25/08.2 Swim England SOG Meeting

Two Swim England SOG Meetings planned for November 24 and 9 January 25 were cancelled. A new meeting is scheduled for 30 January 25. Minutes of the meeting Sept 24 previously circulated. Two Regional Coordinators have resigned, Colin Evison (NW) and Ralph Shortland (London).

### 25/08.3 Swim England SOG Meeting – Judge 2 Applications and Payment

The registration and payment to Swim England direct, still has not been progressed for new applications for training. DM is still receiving applications and chasing up payments. It is expected there will be an update at the SE SOG meeting at the end of the month.

LM asked if this meant that trainees were now doing the theory section online like JL1. DM clarified that only the application and payment was via SE online. Regions/Counties were still expected to deliver the theory and mentoring sections as current.

## 25/08.4 Swim England SOG Meeting – Judge Level 2 Workbooks

DM is still having to notify HA of all new JL2 applications in order that SE can send out the new JL2 handbooks (A5) to the new trainees. This process will stop when the online registration and payment system starts, with the workbooks being sent via an automated process to the trainees. DM stated that he had volunteered SEER to trial the process in East Region before it went live, but to date this has not happened, due to delays in the availability of the software launch.

Regions have concerns that the information received about the new JL2 trainee, may not be in a timely manner. We are all aware of the issues receiving information on new JL1 trainees from SE when it may be up to three months old before we receive it.

### 25/08.5 **Swim England Workflow Project**

No updates on the review of all manual computer input tasks of staff across all disciplines and departments with a view to standardising tasks.

### 25/09 Referee Examinations

25/09.1 Stuart Lundy (Suffolk) passed the November 24 examination and is waiting his poolside assessment in March.

# 25/10.1 Virtual delivery of Judge Level 2/Judge Level 2S (starter) courses by Counties within the Region

DM thanked those who were present who had already volunteered to assist with delivering online training courses. Courses are available until May 2025. He asked those present, including DP for some dates.

DM informed the meeting that 9 trainees had signed up for the JL2S theory course on 21 January 25.

### 25/10.2 **SOLG Zoom Account**

Since July 2024, the leadership group has had access to an exclusive Regional Pro Zoom account (100 attendees) to use in connection with our duties concerning officials training. Positive feedback on how useful the facility is and the ease of access. All agreed it is a useful tool in helping with their roles.

## 25/11 County Updates

A discussion took place by County coordinators as to what was going on within their own Counties and future planning.

Problems /Issues encountered generally etc:

25/11.2 **Bedfordshire** - A new SE Beds website is up and running, although the officials contact email address is not published. LM is waiting for website access and update training. Officials application for counties looking good.

LM reported that AGB had issued a new Disqualification form.

### Post Meeting - HA sent out an email am 16/01/25 stating:

"A new version of the AGB Disqualification form has been uploaded the their website.

This is not as a result of any change to the rules that should be applied. World Aquatics have changed their quick reference page by moving a rule (15.3), reformatting the table and changing the messaging at the top."
